



## **FAMILY CHILD CARE PRE-SERVICE TRAINING REQUIREMENTS**

An **Explore-FCC\*** Practical Help Bulletin

**What is included in this bulletin?**

**If you are exploring becoming a Family Child Care Learning Home (FCCLH), before you apply for a license, you will need to complete 10 hours of training in 5 preservice training topics. In this bulletin you will learn:**

**Why are there 5 preservice training areas?** Bright from the Start: Georgia Department of Early Care and Learning (DECAL) is “responsible for meeting the child care and early education needs of Georgia's children and their families.” In an effort to ensure that Family Child Care Learning Home (FCCLH) providers understand their roles and responsibilities and are prepared to provide high quality early care and education to the children and families in their programs, DECAL developed a set of 5 Workforce Knowledge and Competency areas in which FCCLH providers should obtain training, prior to obtaining a license for care. In addition, there are also 9 Workforce Knowledge and Competency areas for Program Administrators /Educational Leaders, several of which are applicable to FCCLH providers, since there is a dual role of both administrator and teacher.

In developing requirements for Pre-Service Training for FCCLHs DECAL organized the training around 5 Topic Areas. They are: 1: Early Learning Standards and Developmentally Appropriate Practices, 2: Communication, 3: Professional and Leadership Development, 4: Business Management, and 5: Advocacy for the Parents, Children, and Staff in the Family Child Care Learning Home.

Topic Areas are then divided into standards related to Early Childhood Education (ECE) or Administration (ADM) and for each of these, there is a numbered statement of standards. For example, Topic Area 3 Communication lists 3 ECE standards and 1 ADM standard (for the complete list see Appendix).

**Why are ten hours required?** Each topic area identifies standards (a skill or knowledge that ideally, you should obtain to work effectively with children, parents, and the community and to manage your FCCLH). It is not possible to obtain these standards all at once. For example, in Competency Area 1: Early Learning Standards and Developmentally Appropriate Practices, there are 10 ECE standards. Instead of DECAL saying you must take preservice training on all ten standards, you have the option to choose which standard you would like to obtain your two hours of training in under this topic. After you receive your license, you will have opportunities to take training on additional standards.

To say it differently, DECAL determined that 2 hours of training in each of the 5 topics (10 hours total) is enough pre-service training to provide you with the foundational knowledge and skills necessary to begin your FCCLH. In addition, they gave you some freedom to choose which standards and which training you would like to start with. So, as you begin, you can decide which standards are most important to you and hopefully find a training session that most meets your interests or needs.

**NOTE:** While DECAL reviews training content to ensure that standards are met, titles of trainings are determined by the individual trainer and not DECAL. It is up to you to ensure that the training you are taking meets your needs. Carefully review the detailed description of the training to identify exactly which standards are addressed prior to registering.

**Who is responsible for ensuring that you take the right courses- you, the trainer, or DECAL?** It is your responsibility to make sure you complete at least 2 hours of training in each of the five topic areas. Each topic area has several competencies listed to fulfill the area. It is up to the potential provider to know which competency standards the training address before registering for the training

**How do I find the training?** Training can be found on the Georgia Professional Development System website at <https://gapds.dec.al.gov/>. Training opportunities are listed by title and each training description includes a statement of which competency standards will be met. Be sure to review the full description to ensure you're taking the correct competency standards. Some trainers have created courses or bundled courses called "FCCLH Pre-Service Training Course" – these courses are a minimum of 10 hours and contain at least 2 clock hours on each of the 5 topic areas and would be the simplest way for you to obtain these hours.

There are also training sessions listed on the six Georgia Child Care Resource & Referral (CCR&R) agencies' websites. A CCR&R offers ways for providers and potential providers to reach their training and professional needs and goals. To find

**Can training be broken into one (1) or two (2) hours for the topic area?** Yes. Within the topic area, each person will need two (2) hours of DECAL-approved training. *Example:* Topic Area 1: Early Learning Standards and Developmentally Appropriate Practices.

There could be an approved training entitled “Teaching Using the Environment; Competency: ECE1:2” and the training hours are listed as two (2) hours. If you took that course, you would fully meet the requirement for two (2) hours in topic area 1.

**OR**

You could take two, one (1) hour courses and meet the requirement for two (2) hours in Topic Area 1. For example, you could take **both** “Using the Classroom to Plan Appropriate and Responsive Learning Experiences”; Competency: ECE1.2 for 1 (one) training hour and “Using the GELDS”; Competency 5.2 for 1 (one) training hour. By taking both one (1) hour trainings you meet the requirements of two (2) hours for Topic Area 1.

**Is there a charge for the training?** Some trainers may charge for training but there are several free training opportunities. Training can be done by public sectors such as DECAL staff, Child Care Resource & Referral (CCR&R) staff, or by a private individual trainer. The cost of the training varies from free to personal trainers combining the 10-hour pre-service pieces in one package, and starting costs being around \$75.00 or more. It is up to you to find training that both meets your needs and your budget.

**Is there financial assistance to help with paying for training?** Unfortunately, under normal circumstances, there are no funds available to pay for training. But if you live in one of the United Way of Greater Atlanta’s 13 counties and are enrolled in the PFCCAG Explore-FCC project, there are some limited funds to reimburse your training costs. Please see the “More About Us” section below.

**Is pre-service training face to face or virtual?** Training is delivered in a variety of ways. There are options for face-to-face training, live scheduled virtual training, prerecorded virtual training, and “work at your own pace” 24 hours a day virtual training. A list of training sessions can be found on the GaPDS site.

**How far in advance can I take the training?** Pre-Service Training must be taken within 12 months before submitting your Family Child Care Learning Home Applicant Packet.

**At least two (2) hours from the competency areas below is required**

- ECE 1.1: Using knowledge of young children's characteristics, cultural and linguistic backgrounds, and their needs to plan appropriate and responsive learning experiences
- ECE 1.2: Using knowledge of the multiple influences on development and learning to create inclusive and responsive learning environments
- ECE 1.3: Using developmental knowledge to create healthy, respectful, supportive, and stimulating learning environments and relationships
- ECE 1.4: Creates emotionally and physically safe environments for children
- ECE 5.1: Utilizing the GELDS as a framework for growth and development
- ECE 5.2: Utilizing content knowledge in the GELDS Physical Development and Motor Skills domain, selects, implements, and evaluates developmentally appropriate activities for each and every child, taking into consideration cultural context, home language, and individual needs
- ECE 5.3: Utilizing content knowledge in the GELDS Social and Emotional Development domain, selects, implements, and evaluates developmentally appropriate activities for each and every child, taking into consideration cultural context, home language, and individual needs
- ECE 5.4: Utilizing content knowledge in the GELDS Approaches to Play and Learning domain, selects, implements, and evaluates developmentally appropriate activities for each and every child, taking into consideration cultural context, home language, and individual needs

### **Competency Topic Area 2: Communication**

**At least two (2) hours from the competency areas below is required**

- ECE 2.1: Fostering family engagement in the child's educational experiences
- ECE 2.2: Developing partnerships with families
- ECE 2.3: Utilizing community resources
- ECE 3.3: Sharing, reporting, and communicating assessment, observation, or developmental screening data while maintaining supportive and respectful family partnerships

- ECE 4.1: Developing positive relationships with each and every child
- ECE 4.3: Intentionally planning and preparing a learning environment that nurtures each and every child's initiative, encourages active exploration of materials, supports engagement with activities, and encourages interactions with others

**Competency Topic Area 3: To market the program to parents and the community.  
At least two (2) hours from the competency areas below is required**

- ECE 6.1: Engages in professional and ethical behavior
- ECE 6.2: Demonstrating a commitment to ongoing professional learning
- ECE 6.3: Building collaborative relationships
- ADM 7: To foster good community relations and to influence child care policy that affects the program

**Competency Topic Area 4: Business Management  
At least two (2) hours from the competency areas below is required**

- ADM 1: To develop and maintain an effective organization
- ADM 5: To maintain and develop the facility and equipment
- ADM 8: To practice responsible fiscal management

**Competency Topic Area 5: Advocacy for the Parents, Children, and Staff in the Family Child Care Learning Home.  
At least two (2) hours from the competency areas below is required**

- ECE 3.3: Sharing, reporting, and communicating assessment, observation, or developmental screening data while maintaining supportive and respectful family partnerships
- ADM 7: To foster good community relations and to influence child care policy that affects the program
